Ticket Refund or Roll-over Request Instructions:

Tickets purchased to the 2020 Logan County Fair and Rodeo can either be refunded or transferred to 2021. We require a Ticket Refund or Roll-over Request Form to be completed by the patron who purchased the tickets. All request forms must be submitted before December 31, 2020. Any tickets pending action after December 31, 2020, will be automatically rolled to 2021. **Season ticket holders** will be able to retain the seats they upgraded to even if they have decided to receive a refund.

To request a full refund:

Complete the top portion of the request form as well as the patron credentials at the bottom of the page. Fill in the blanks with the patron name (must be the name of the ticket purchaser). Circle that you are requesting your full order to be refunded. Fill in your order number. This will be found on the top right corner of your ticket confirmation or the barcode of your ticket stub. If you are requesting a full refund, you do not need to specify which seats. We will refund your entire order.

To request a full roll-over:

Complete the bottom portion of the request form as well as the patron credentials at the bottom of the page. Fill in the blank with the patron name (must be the name of the ticket purchaser). Circle that you are requesting all tickets to be rolled over to 2021. Fill in your order number. This will be found on the top right corner of your ticket confirmation or the barcode of your ticket stub. If you are requesting all tickets to be rolled over, you do not need to specify which seats. We will roll-over your entire order.

To request a partial refund and partial roll-over:

Complete the top portion of the request form. Fill in the patron name (must be the name of the ticket purchaser). Circle that you are requesting a partial refund. Fill in your order number. This will be found on the top right corner of your ticket confirmation or the barcode of your ticket stub. List the specific section, row, and seats that you are wanting to be refunded. Then complete the second portion of the request form. Fill in the patron name, circle some tickets, and fill in the order number. List the specific section, row, and seats that you are wanting to roll over to 2021. Be sure to complete the bottom portion containing patron credentials.
