## 2022 Demolition Derby Request for Proposal

The Logan County Commissioners and the Logan County Fair Board are accepting bids for a Demolition Derby event to be held on August 7, 2022 at 5:30 p.m. in the main arena of the Logan County Fairgrounds.

The bid shall include:

1. Provide all Judges and make provisions for any other clerical crew personnel needed for the event.
2. Coordinating the Event Schedule; Racing Format; Scheduling of Heats; Judging; Scoring; the Timing of the Heats; and Registration of participants for the Event
3. Provide Logan County Fair & Rodeo with all monies collected for the event by the conclusion of the event.
4. Provide Logan County Fair & Rodeo a list of all winners.
5. Provide proof of One Million dollars (\$1,000,000.00) of Comprehensive General Liability insurance.
6. Any changes to these requirements must be noted on your bid and subject to the approval of the Logan County Fair Board.
7. This will be for three (3) consecutive years 2022, 2023, 2024.
8. The Logan County Fair Board will be responsible for the advertising, ticket sales, provide wreckers to remove participants from arena, road grader, water truck, ambulance, fire truck and personnel to operate them.
9. Logan County Fair & Rodeo will provide purse money to Contractor in an amount determined by mutual agreement of the Logan County Fair Board and the Contractor, in one lump sum at least seven (7) days prior to the Event, to be distributed by the Contractor to the winners the night of the Event in the form of separate checks issued by the Contractor.
10. Price for tickets will be set by Logan County Fair Board.
11. Added attractions i.e. Campers or other vehicle types are negotiable with the Logan County Fair Board.

Specifications will be met or payment will be withheld.

Submit your proposal to the Logan County Fair Board by 5 p.m. on December 3, 2021. All proposals should be submitted in a sealed envelope and marked with "Demolition Derby". The Fair Board will be opening the Proposals on December 9, 2021, at the Fair Board meeting. Notification will be December 15th, after the Commissioners have approved the proposal. Supporting paperwork should include name of organization, address, supervising agent, telephone number, proposed amount, and proof of insurance.

The Board of Commissioners reserve the right to reject any or all bids and to accept the proposal deemed to be in the best interest of Logan County.
